THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION, EACH A NATURAL PERSON COMPETENT TO CONTRACT, HEREBY ASSOCIATE THEMSELVES TOGETHER TO FORM A CORPORATION FOR NOT FOR PROFIT UNDER THE LAWS OF THE STATE OF FLORIDA.

**ARTICLE 1. NAME & MAILING ADDRESS**

THE NAME OF THIS CORPORATION IS: MIRA FOUNDATION, INC. AND ITS MAILING ADDRESS IS 8050 WEST MCNAB RD # 108, TAMARAC, FLORIDA 33321.

**ARTICLE II. PURPOSE**

**ARTICLE V. DIRECTORS**

### **ARTICLE IX. DISSOLUTION**

UPON DISSOLUTION OR BREAKING UP OF THIS CORPORATION, ITS ASSETS REMAINING AFTER PAYMENT OR PROVISION FOR PAYMENT OF ALL DEBTS AND LIABILITIES OF THE CORPORATION, SHALL BE DISTRIBUTED TO A NON-PROFIT FUND, FOUNDATION OR CORPORATION WHICH IS ORGANIZED AND OPERATED EXCLUSIVELY FOR CHARITABLE PURPOSES AND WHICH HAS ESTABLISHED ITS TAX EXEMPT STATUS UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE OF 1954, OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAWS.
