ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The terms of the directors shall be perpetual. Any vacancies on the Board of Directors, whether occurring by resignation, death or incapacity of a director, or for any other reason whatsoever, shall be filled by the remaining directors.

The members of the Corporation shall only have the right to vote for directors in the event all positions on the Board of Directors are vacant, for whatever reason. Thereafter, the Members shall have the right to vote for Directors at each annual meeting of the Corporation.

A copy of the proposed changes shall be mailed to all Members at least ten (10) days prior to the meeting date.
- II. In the event the Members acquire the right to elect the directors of this Corporation, pursuant to Article VI, then in that event, the Articles of Incorporation of the Corporation may be amended, repealed or altered in whole or in part by a majority vote at any duly organized meeting of the Members at which a quorum shall be present. Notice of the proposed changes shall be mailed to each Member at his or her last known address at least ten (10) days prior to the time and date of the meeting which is to consider and vote on the action before the meeting.

The proposed change or amendment to these articles of Incorporation shall, prior to notice being given of such meeting, be ratified and approved by the Board of Directors by a majority vote of the directors present at such Board of Directors meeting. Only those directors present may cast their vote on the action before the meeting.
