ARTICLES OF INCORPORATION

OF

NEW TESTAMENT COMMUNITY FELLOWSHIP OF WALTON COUNTY, INC.

Articles of Incorporation of the undersigned, a majority of which are citizens of the United States, desiring to form a non-profit corporation under the Nonprofit Corporation Law of the State of Florida, do hereby certify:

ARTICLE ONE

NAME

The name of the corporation is New Testament Community Fellowship of Walton County, Inc.

ARTICLE TWO

PRINCIPAL OFFICE

The place in this state where the principal office of the corporation is to be located is 262 N. 9th Street, DeFuniak Springs, Walton, County, Florida 32433.

ARTICLE THREE

REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 262 North 9th Street, DeFuniak Springs, Florida, 32433, and the name of its initial registered agent at such address is W.N. "Jack" Frost.

ARTICLE FOUR

PURPOSE OR PURPOSES

This corporation is organized exclusively for religious purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

ARTICLE FIVE

ARTICLE SEVEN **CORPORATE NET EARNINGS; ACTIVITIES**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, directors, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on or propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles of incorporation, the corporation shall not

carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

ARTICLE EIGHT
DEDICATION OF ASSETS TO RELIGIOUS PURPOSES;
DISTRIBUTION ON DISSOLUTION

The assets of this corporation are irrevocably and permanently dedicated to religious and charitable purposes. Upon the dissolution of the corporation, its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as such court shall determine, that are organized and operated exclusively for such purposes.
