The undersigned incorporator, for the purpose of forming a corporation not for profit under the Florida Business Corporations Not For Profit Act, hereby executes the following Articles of Incorporation.

ARTICLE I -- NAME

The name of the corporation shall be

ARTICLE II -- ADDRESS

ARTICLE III -- PURPOSES

This corporation is organized exclusively for charitable, educational and scientific purposes, including for such purposes the making of distributions to organization under section 501(c)3 of the Internal Revenue Code (or the corresponding section of any future Federal tax code).

ARTICLE IV -- POWERS

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted Adopted March 14, 1998

to be carried on by a corporation exempt from federal income tax under section 501(c)3 of the Internal Revenue Code (or corresponding section of any future tax code) or by a corporation or organization contributions to which are deductible under section 170(c)2 of the Internal Revenue Code (or the corresponding section of any future tax code).

ARTICLE V -- MEMBERS, OTHER PERSONS, AND EARNINGS

A. No part of the net earnings of the corporation shall inure to the benefit of its members, trustees, directors, officers or other private persons except that the corporation shall be authorized to pay reasonable amounts for services rendered and to make payments and distributions in furtherance of section 501(c)3 purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

B. The qualifications of the members, the manner of their admission and termination of membership, and voting by members shall be as stated in the By-Laws.
