ARTICLES OF INCORPORATION

OF

MINISTERING ARTISTS, INC.

I.

The name of the Corporation is Ministering Artists, Inc.

II.

The purpose for which the nonprofit corporation is formed is to engage in sharing and preserving authentic, cultural heritage through various forms of artistic media.

Specifically, the Corporation shall mobilize money and volunteer workers to assist the community in presenting original productions.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, and the Corporation shall not participate in, or intervene in (including the publishing or distributing of statements) any political campaign for public office.

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the objects and purposes noted herein.

Upon the dissolution of the Corporation, the Board shall, after paying or making provisions for the payment of all the liabilities of the Corporation, dispose of all of the assets of the Corporation in the following manner: (i) any remaining assets shall be given to such organization or organizations as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, as the Board shall determine.

III.

The duration of the Corporation shall be perpetual.

IV.

The Corporation shall be nonprofit.

V.

The location of the Corporation's registered office shall be 725 Monroe St. Jacksonville, Fl. 32202

VI.

The name and address of the Corporation's registered agent shall be Wilene D. Dozier, Esquire, 200 W. Forsyth St. Suite 800, Jacksonville, Fl. 32202.

VII.

The name and address of the Corporation's incorporator is Wilene D. Dozier, Esquire, 200 W. Forsyth St. Suite 800, Jacksonville, Fl. 32202

VIII.

The names and addresses of the initial Board of Directors are:

Said Board members shall hold office until the regular board with its members and numbers, and regular officers, are constituted and appointed by the initial Board through the Corporation's articles and bylaws.

IX.

Ultimate authority in the Corporation shall reside in its Board of Directors.

X.

The Corporation shall have no members and no stock.

XI.

These articles may be amended by vote of 2/3 of the qualified members of the Board of Directors.

XII.

No mere informality in organization shall have the effect of rendering these articles of incorporation null or of exposing the Board of Directors or any other members of this Corporation to any liability other than as above provided.
