ARTICLES OF CORPORATION

FOR

CORPORACION MOVIMIENTO PENTECOSTAL CANTARES 6.9

The undersigned, acting as a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Corporation:

ARTICLE I NAME

CORPORACION

This Corporation shall be known as the MOVIMIENTO PENTECOSTAL CANTARES 6.9, CORP. Translated: PENTECOSTAL MOVEMENT CANTARES 6.9, CORP.

ARTICLE II LOCATION

The principal place of business of this Corporation shall be:

ARTICLE III OBJECTIVES AND PURPOSES

The objectives and purposes of the Corporation are:

To instruct and to prepare ministries for the service of God; to organize, seek donations, recruit volunteers and transact any or all lawful business necessary for the execution of the goals of the corporation Known as MOVIMIENTO PENTECOSTAL CANTARES 6.9"; as are the pursue of the well-being, provide spiritual wealth, counsel all those who seeks them; to provide assistance whether spiritually, physically, and/or financially to the Movimiento Pentecostal Cantares 6.9; and dispense happiness for its members and the community in general.

Exercise all rights and powers conferred by the laws of the State of Florida unto non-profit, nonstock corporations. To do such other acts as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

That our goal is to unite and not to divide.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

This manner in which the directors are selected or appointed is as follows:

Directors must be volunteers and must be willing to actively participate in the development of activities within the "MOVIMIENTO PENTECOSTAL CANTARES 6.9" and within residents of Central Florida Area of the State of Florida; and, any to possess all other qualification as required in the by-laws of the Corporation.

The election of Directors shall be specified in the by-laws.

<u>Section 1. Termination</u> Membership in the Corporation's Board of Directors shall be terminated in the following circumstances:

- a. Voluntary withdrawal by a member upon written notification to the Pastor & President.
- b. Failure of a member to continue to meet the duties.

ARTICLE VI LIMITATION OF CORPORATE POWERS

The corporate power of this Corporation are as provided in section 617.0302 or Chapter 617.0202 of Florida Statutes.

ARTICLE VII BOARD OF DIRECTORS

<u>Section 1. General.</u> The affairs of the Corporation shall be managed by a Board of Directors consisting of 3 individual delegates of Regular Unit Members elected by the Regular Unit Members at an annual general meeting.

Section 2. Designation. The Pastor and President will always be Dora Alamo.

ARTICLE VIII FINANCES

- 1. That the funds sustaining the expenses of the church will be obtained thru the voluntary offerings, and the concept of tithing of all the members.
- 2. That the offerings be taken up in every service and named by the Pastor. The offering will be over to the treasury, where it will be deposited in a security box, until the funds can be deposited in the bank account of the church.
- 3. That no loans be made from the ordinary funds.
- 4. That all funds of the Corporation shall be maintained in an account or accounts in the name of the Corporation. The Pastor and Treasurer shall be authorized to draw funds from any account.
- 5. That any property, furnishings, any other item needed to be sold, because it is no longer needed, the proceeds received from sale of items be transferred into the Church's funds.
- 6. That the church will help it's members with their necessity, forefilling therefore with it's responsibilities.
- 7. That the Pastor will receive an offering from the church funds according to her or his needs or life necessities.
- 8. To pursue of the well-being and provide financial assistance.
- 9. For travel and or vacation expenses of the Pastor.
- 10. For doctor and or hospital expenses in event of sickness or disability.
- 11. For social and financial assistance to the community in general.
- 12. To help and prepare ministries for the service of God.

- 13. To help missionaries.
- 14. For emergency expenses.
- 15. For petty cash and or miscellaneous expenses.
- 16. For any church activity.
- 17. For buying any land, new property, building or construction site for the expansion on the ministry. This will require the Board of Directors full approval.
- When the ministry have grow, the funds could be also use to pay various wage salaries. Occupations such as Secretary, Accountant, Janitor, Maintenance, etc.
- 19. If any equipment, non furniture or assets were sold, the money should go to the Corporation's bank account.

ARTICLE IX PROPERTIES

That all properties of the Corporation be written in the Corporation's name, and be always maintained as such. No property acquired by the Corporation may be sold, auctioned, turned over, without the Board of Directors approval.

ARTICLE X DISSOLUTION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations that the pastor will choose, which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954.

Section 1. Distribution on Liquidation.

- A. Funds Any funds remaining in the Corporation's account after the payment of all expenses, shall be used to provide financial assistance, to pay any rental expenses or to pay any property maintenance.
- B. Properties If any of the properties any debt, it should be sold or liquidated. If the property has no debt, it will be turned over to one organization that the Pastor and President will choose. In case of the Pastor's death, the Board of Directors, Treasurer, Secretary and Vocal, will decide which organization will be turned over to.
- C. Debts They should be liquidated with the sale of any equipment such as electrical, musical, office, computer, etc. In addition to any vehicles that are Corporation's property.

D. Vehicles, furniture and non furniture items - If any vehicles, furniture or non furniture items have any debt, it should be sold, liquidated or turned over to the bank or debtor. If there is no debt, it will be turned over to one organization that the Pastor and President will choose. In case of the Pastor's death, the Board of Directors, Treasurer, Secretary and Vocal, will decide which organization will be turned over to.

Section 2. In case of any money left after any transaction mentioned above, the money should be turned over to the Corporation's bank account.

Section 3. If the pastor will decide to leave to Incorporate, to expand the ministry inside the Corporation, the Pastor will appoint a new Pastor. In addition, the Pastor could choose to be Incorporated to another organization with the same religious doctrine. (Ref. Doctrine manual) In case of the death of the Pastor, and the Corporation will choose to be and stay at the same place, the Board of Directors and officers of the Corporation will decide to be Incorporated to another organization or church with the same religious doctrine. In the other hand, by a general meeting the Board of Directors by a general meeting could elect another Pastor with the same religious doctrine.
