**ARTICLES OF INCORPORATION**

**OF**

**VOTERS CONSTITUTIONAL RIGHTS DEFENSE ASSOCIATION, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be: **VOTERS CONSTITUTIONAL RIGHTS DEFENSE ASSOCIATION, INC.**

**ARTICLE II - NOT FOR PROFIT**

The corporation is a not for profit corporation under the laws of the State of Florida. The corporation is not formed for pecuniary profit. Not part of the corporation is distributable to or for the benefit of its members, Trustees or officers, except to the extent permissible under the law.

**ARTICLE III - PURPOSES**

The purposes for which the corporation is formed and the business and objects to be carried on and promoted by it are as follows:  
To educate and guide the voters on election procedures and to advance the democratic process under our system of government by recognizing the importance of an informed electorate.

**ARTICLE IV - TERM**

This corporation shall commence existence on the date of the filing of these Articles of Incorporation and shall have perpetual existence.

**ARTICLE V - INITIAL REGISTERED AGENT AND STREET ADDRESS**

The Registered Agent for this corporation shall be BENIGNO PEREDA, and the registered office shall be located at 323 S.W. 23rd Avenue, Miami, Florida 33135, or at such other place as the Board of Directors shall from time to time direct, with appropriate notice being given to the Secretary of State in accordance with law. The aforementioned location also constitutes the principal office.

**ARTICLE VI - INITIAL DIRECTORS**

The number of directors constituting the initial Board of Directors shall be three (3), and the names and addresses of the persons who are to serve as directors until the first meeting of the Corporation or until their successors are elected and qualified are:

**ARTICLE VII - SUBSCRIBER**

**ARTICLE VIII - INSPECTION OF BOOKS AND RECORDS**

The corporation shall from time to time determine whether and to what extent and at what times and places and under what conditions and regulations the accounts and books of the corporation (other

than the stock book) or any of them shall be open to inspection of shareholders; and no shareholder shall have the right of inspecting any account, book or document of this corporation except as conferred by statute unless authorized by a resolution of the shareholders or the Board of Directors.

**ARTICLE IX - INDEMNIFICATION OF OFFICERS AND DIRECTORS**

Every officer and every director of the corporation shall be indemnified by the corporation, as permitted by law, against all expenses and liability, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding to which he may be a party or in which he may become involved by reason of his being or having been an officer or director of the corporation, whether or not he is an officer or director at the time such expenses are incurred. The foregoing rights of indemnification shall be in addition to and not exclusive of all other rights to which such officer or director may be entitled.

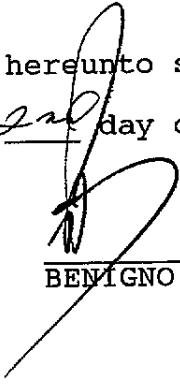
**ARTICLE X - TELEPHONE MEETINGS AUTHORIZED**

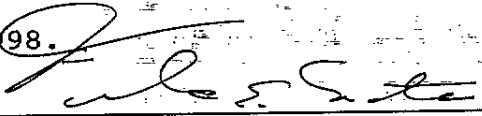

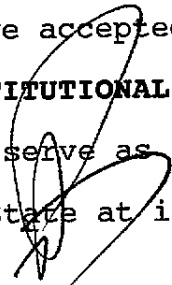

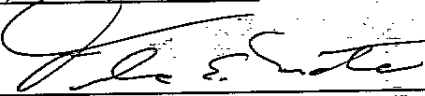
