SO TEBERAL SING ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF Fundanina's Foundation, Inc.

Pursuant to the provisions of Section 617.1006 of the Florida Not-For-Profit Business Corporation Act, Fundamina's Foundation, Inc., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

Amendment

The Corporation's Articles of Incorporation are amended by adding as Article VIII the following language:

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Date of Adoption

The amendment was adopted on the 1st day of February, 1999.

Manner of Adoption

The amendment was adopted by a unanimous resolution of the board of directors of the Company, there being no members.
