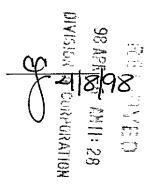

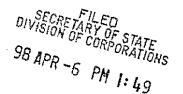

ARTICLES OF INCORPORATION OF



The undersigned, acting as incorporators of a Corporation under the Florida Not For Profit

Corporation Act, Chapter 617, Florida Statutes, adopts the following Articles of Incorporation

ARTICLE I

NAME

The name of the corporation shall be . Sample Oaks Family Home Care Inc.

ARTICLE II

DURATION

The corporation shall have perpetual duration.

ARTICLE III

INITIAL REGISTERED AGENT AND ADDRESS

The principal place of business and the mailing address of this corporation shall be 718 Boston Ave. Fort Pierce Florida 34950, and the name of the initial registered agent at such address is Mrs. H. Rae Pike

ARTICLE IV PURPOSE

The purposes for which the corporation is organized are:

- I. To provide short term services to domestic violence victims.
- 2. To supply transportation for clients seeking employment, housing and education or support services
- 3. To supply appropriate counseling and referral assistance to legal, medical and social systems.
- 4. To provide meals, clothing, personal and household items and furniture.
- 5. To engage in other activities and functions as are proper and in furtherance of the goals and purposes of the corporation.

ARTICLE V BOARD OF DIRECTORS

The Corporation shall have no stockholders. It shall have such members and classes of members as may be designated in the by-laws. Affairs of the corporation shall be managed by a Board of Directors consisting of not less than three (3) members and not more than seven (7) members, herein called Directors, who shall be elected by the members of the corporation in the manner and serve for the term as prescribed in the by-laws. The actual number of Directors to comprise the Board of Directors shall be seven (7) at the outset, and thereafter it shall be such number within the limits set hereby as the by-laws shall state, provided that the by-laws shall have been adopted changing such number. The Board of Directors may delegate specific duties and responsibilities to its corporate officers as prescribed in the by-laws.
