ARTICLES OF INCORPORATION

OF

Orion Foundation. Incorporated

A NON-PROFIT CORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, Hereby adopts the following Articles of Incorporation:

ARTICLE I:

The name of this corporation is: Orion Foundation. Incorporated.

ARTICLE II:

The principal place of business and mailing address of this corporation shall be:

ARTICLE III:

The specific purposes for which this corporation is organized are; to establish a religious organization to promote the teachings of and publish materials of and concerning the Seventh Day Adventist religious organization and for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

OWIGOR OF CORPORATIONS

ARTICLE IV:

The manner in which the directors are elected or appointed is: Directors shall be elected annually, at the regular meeting of directors held on January 2nd of each year, directors shall be elected by the Board of Directors. Voting for the election of directors shall be by written ballot. Each director shall cast one vote per candidate, and may vote for as many candidates as the number of cadidates to be elected to the board. The candidates receiving the highest number of votes up to the number of directors to be elected shall be elected to serve on the board.

Additional provisions are: Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activites of this corporation shall consist of carring on propaganda, or otherwise attempting to influence legislation [except as otherwise provided by Section 501 (h) of the Internal Revenue Code] and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any polical campaign on behalf of, or in opposition to, any candidate for public, office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distrutable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Articals.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activites not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
