Pursuant to the provisions of section 617.1006, Florida statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

FIRST:

Article 7 of the Articles of Incorporation states the following:

This Corporation shall have perpetual existence.

SECOND:

Article 7 shall be amended to state:

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501© (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

THIRD:

Article 8 of the Articles of Incorporation states the following;

This Corporation shall have no capital stock and shall be composed of members rather than shareholders.

FOURTH:

Article 8 shall be amended to state:

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501© (3) and 170© (2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

FIFTH:

The Date of the adoption of this amendment is the 11 May 1999 by the

Members.

SIXTH:

The Board of Directors has adopted a resolution setting forth this amendment of the Articles of Incorporation of the corporation. Said resolution was submitted to a vote at a special meeting of all of the Members of corporation entitled to vote thereon. The amendment to the Articles of Incorporation was adopted unanimously by all of the Members at such meeting. The number of votes cast for the amendment was sufficient for approval.

SEVENTH: This amendment shall be effective upon the filing of these Articles of Amendments to Articles of Incorporation of DEAF EXPERIENCE ASSOCIATION, INC.
