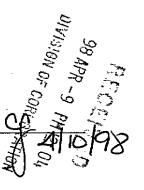

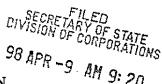

# ARTICLES OF INCORPORATION

OF.

# DISABILITIES & RELIGION PROJECT OF FLORIDA, INC.

The undersigned, desiring to form a corporation not for profit under Chapter 617 of the Florida Statutes, does ordain and establish these Articles of Incorporation.

### ARTICLE I.

The name of the corporation is DISABILITIES & RELIGION PROJECT OF FLORIDA, INC.

### ARTICLE II.

The street address of the principal office of the corporation is 3520 Cleveland Heights Boulevard, Suite 132, Lakeland, Florida 33803, and the mailing address of the corporation is 3520 Cleveland Heights Boulevard, Suite 132, Lakeland, Florida 33803.

# ARTICLE III.

The purposes for which the corporation are organized are as follows:

- A. To promote the inclusion of all persons with disabilities in each aspect of religious worship.
- B. To encourage places of worship to embrace, love, support, and minister to parishioners with disabilities and their families.
- C. To encourage the development and implementation of emotional and physical systems of support for persons with disabilities.
- D. To assist in the removal of attitudinal and architectural barriers that now confront persons with disabilities.

# ARTICLE IV.

The corporation shall have one or more classes of members. The designation of such class or classes, the qualifications and rights of the members of each class, any quorum and voting requirements for meetings and activities of members, and notice requirements sufficient to provide notice of meetings and activities of the members, to the extent not inconsistent with

these Articles of Incorporation, shall be as set forth in the Bylaws of the corporation, as initially adopted and as from time to time amended.

### ARTICLE V.

The method of electing directors of the corporation shall be as stated in the Bylaws of the corporation, as initially adopted and as from time to time amended.

## ARTICLE VI.

The street address of the corporation's initial registered office is c/o Wendel, Chritton & Parks, Chartered, 5300 South Florida Avenue, Lakeland, Florida 33813, and the name of its initial registered agent at that address is John Paul Parks.

### ARTICLE VII.

The name and address of the sole incorporator of the corporation is John Paul Parks, c/o Wendel, Chritton & Parks, Chartered, 5300 South Florida Avenue, Lakeland, Florida 33813.

### ARTICLE VIII.

- A. No part of the net earnings of the corporation shall inure to the benefit of any member, director, or officer of the corporation, nor to the benefit of any private individual.
- B. The corporation shall have no power to engage in any act or activity prohibited to corporations which are exempt from federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding Sections of any prior or future Internal Revenue Code.
- C. In the event of the dissolution of the corporation, the residual assets of the corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any prior or future Internal Revenue Code, or to the federal or to a state or local government for public purposes exclusively.

# ARTICLE IX.

These Articles of Incorporation may be amended by a two-thirds vote of those directors present at a meeting of the Board of Directors at which a quorum is present. The Bylaws of the corporation may be adopted, altered, amended, or repealed by a two-thirds vote of those

directors present at a meeting of the Board of Directors at which a quorum is present.
