**ARTICLES OF INCORPORATION
A NON PROFIT ORGANIZATION**

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation pursuant to Chapter 617, Florida Statutes, providing for the formation of a corporation for non-profit, with the powers, rights, privileges and acknowledge and file with the Secretary of the State of Florida.

ARTICLE I

The name of the corporation is: **SEEDS OF GRACE MINISTRIES, INC.** and the initial principal address of the corporation is: **190 NE 33RD STREET, OAKLAND PARK, FL 33334.**

ARTICLE II

The period of duration of this corporation is perpetual unless dissolved according to the law.

ARTICLE III

Notwithstanding any other provision of these articles, the purpose for which the organization is organized are exclusively religious, charitable and education within the meaning of Section 501(c)(3) of the Internal Revenue Code or the corresponding provision of all bearing similar religious beliefs as set forth in the corporate bylaws.

ARTICLE IV

The qualifications for members and the manner of their admission is to be provided for in the Bylaws.

ARTICLE V

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the present Internal Revenue Code, or to the Federal, State or Local government for exclusive public purpose.

ARTICLE VI

ARTICLE VII

The number of directors constituting the initial Board of Directors of the corporation is 4, and the members of the Board of Directors shall be elected and hold office in accordance with the bylaws for the conduct of its business and the carrying out of its purpose as they deem from time to time.

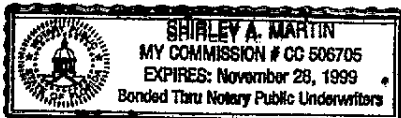
