ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: THE COUNTRY CLUB MANOR ASSOCIATION, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is:301 Clubhouse Drive, Eustis, Fl 32726

ARTICLE III PURPOSES

The general purpose for which the corporation is organized is to promote the welfare, safety, communication and enjoyment of and among the residents of Country Club Manor, to engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith.

The specific purpose of this association is to represent home-owner residents of Country Club Manor mobile home park, who are non-shareholders in the Country Club Manor CO-OP (resident owners of the park who are share-holders) in any and all dealings with the park owners.

This corporation shall have the power to transact any and all lawful business for which corporations may be incorporated under Chapter 617, F.S., 1995.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected is:

Directors shall be elected at the annual meeting of the members in the manner set forth in the By-Laws. They shall be elected from the members of the association. They may be removed, and their vacancies filled, in the manner provided in the By-Laws. The directors shall be no fewer than three(3) in number, and shall be the officers of the corporation. Their terms of office are as set forth in the By-laws.
