# ARTICLES OF INCORPORATION OF

Pine Tree Park Subdivision ASSOCIATION, INC.

The undersigned, acting as incorporators of a Corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

# ARTICLE I - NAME

The name of the corporation shall be

Pine Tree Park Subdivision Association, Inc.

# ARTICLE II - DURATION

The corporation shall have perpetual duration.

ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

The principal place of business and the mailing address of this corporation shall be 307 North 30th Street; Fort Pierce, F1.- 34947

and the name of the initial registered agent at such address is Dorothy Ingram

# ARTICLE IV - PURPOSE

The purposes for which the corporation is organized are:

- 1. To maintain the living surrounding including fences, landscaping and entrance signs, in an attractive manner which will enhance the value of homes within the subdivision.
- 2. To collect dues and administer funds for the benefit of the subdivision.
- 3. To enforce the Rules and Regulations, as adopted from time to time by the membership.
- 4. To help solve problems among homeowners which affect the quality of life within the subdivision.

5. To engage in other activities and functions as are proper and in furtherance of the goals and purposes of the corporation.

#### ARTICLE V - BOARD OF DIRECTORS

The Corporation shall have no stockholders. It shall have such members and classes of members as may be designated in the By-Laws. Affairs of the corporation shall be managed by a Board of Directors consisting of not less than three (3) members and not more than eight (8) members, herein called Directors, who shall be elected by the members of the corporation in the manner and serve for the term as prescribed in the By-Laws. The actual number of Directors to comprise the Board of Directors shall be five (5) at the outset, and thereafter it shall be such number within the limits set hereby as the By-Laws shall state, provided that the By-Laws shall have been adopted changing such number. The Board of Directors may delegate specific duties and responsibilities to its corporate officers as prescribed in the By-Laws.

#### ARTICLE VI - INITIAL BOARD OF DIRECTORS

The names and addresses of the persons who shall serve as Directors until the first annual meeting of members, or until their successors shall have been elected and qualified, are as follows:

#### ARTICLE IX - INDEMNIFICATION

As partial inducement to the Directors and Officers of the corporation to accept such positions, the corporation is and shall .... henceforth be obligated to indemnify and hold harmless all Directors and Officers of the corporation, whether or not their terms shall have expired, of and from any loss, expense, and liability or claimed liability of every kind whatsoever which they may at any time pay or incur as a direct or indirect consequence of any actions taken or omitted or alleged to have been taken or omitted by the corporation, by other Directors or Officers or by themselves as such Directors and Officers, accepting only such as may be paid or incurred in relation to matters as to which they respectively shall be adjudged by action, suit or proceeding to be liable for negligence or misconduct in the performance of their duties for the corporation. Such indemnification shall cumulative and not exclusive of any other rights to which the Directors or Officers may be entitled under any laws, agreements, corporate actions or otherwise.

# ARTICLE X - BY-LAWS

The Board of Directors may adopt and amend from time to time such By-Laws as it deems advisable which shall not be inconsistent with these Articles or with the Florida Not for Profit Corporation Act.
