On the 7th day of March, 2000, the Articles of Incorporation for the

William A. Peters Family Foundation, Inc. are hereby amended to include the following provisions:

Item 1. Notwithstanding any other provisions of these Articles, this organization shall not engage in any activities not permitted to be carried on by an organization exempt from Federal Income Tax under § 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Item 2. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes when it is in the meaning of § 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding sections of any future federal tax code, or shall be distributed to the federal, state or local government for a public purpose. Any assets not so disposed of, shall be disposed by the circuit court of the county in which the principal office is a corporation is then located, exclusively for such purposes.
