ARTICLES OF INCORPORATION OF FLORIDA READING ASSOCIATION, INC. (A Corporation Not For Profit)

THE UNDERSIGNED, has executed the following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights duties and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the provisions of the laws of the State of Florida.

ARTICLEI

The name of this corporation shall be Florida Reading Association, Inc.

ARTICLE II

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of State, State of Florida, and shall have perpetual existence.

ARTICLE III

The principal place of business, location and mailing address of this corporation shall be:

ARTICLE IV

The general nature of the business and objects and purposes proposed to be transacted and carried on by this not-for-profit corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural persons might do, viz.:

- (1) Transact any and all lawful business, including but not limited to operation of a not-for-profit business concerned with the sole purpose of furthering the improvement of reading. It is the desire of said institution to become incorporated under the laws of Florida as a not-for-profit corporation. Said institution may hold property and transact business which is necessary in its endeavor to accomplish the following stated purposes, among others:
 - (a) To improve the quality of reading instruction at all levels by:
 - 1. encouraging the study of the nature of the reading process.
 - 2. stimulating and promoting research dealing with all aspects of reading,
 - acting as a clearinghouse for information relating to reading,
 - 4. encouraging the development of high quality teacher education programs, both preservice and inservice, and
 - 5. sponsoring conferences and meetings.
 - (b) To develop an awareness of the impact of reading among all individuals by:
 - 1. encouraging the development of worthwhile reading tastes and permanent interests in reading,
 - 2. promoting the formation of lifetime habits of reading, and
 - developing an appreciation of the value of reading.

- (c) To promote the development among all individuals a level of reading proficiency that is commensurate with each individual's unique capacity.
- (d) To be actively involved with legislative matters that deal directly with the goals of this institution.
- (2) Said corporation shall further have powers:

To receive gifts and contributions;

To have perpetual succession by its corporate name;

To sue and be sued, complain, and defend in its corporate name in all actions or proceedings;

To have a corporate seal, which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed, affixed, or in any other manner reproduced;

To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use, and otherwise deal in and with real or personal property or any interest therein, wherever situated, by grant, gift, purchase, devise or bequest, and hold and dispose of such property as the corporation shall require for the purposes and objects of the corporation and not for pecuniary profit;

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;

To lend money to, and use its credit to assist, its officers and employees in accordance with Florida Statutes;

To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend,

pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, government district, or municipality or of any instrumentality thereof;

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises, and income;

To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security of the payment of funds so loaned or invested:

To conduct its business, carry on its operations, and have offices and exercise the powers granted by this act within or without this State:

To elect or appoint officers and agents of the corporation and define their duties and fix their compensation;

To make or alter bylaws, not inconsistent with its articles of incorporation or with the laws of the State, for the administration;

To make donations for the public welfare or for charitable, scientific, or educational purposes;

To transact any and all lawful business which the board of directors shall find will be in aid of governmental policy;

To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans, and other incentive plans for any or all of its directors, officers, and employees and for any or all of the directors, officers, and employees of its subsidiaries;

To be promoter, incorporator, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other enterprise;

To have and exercise all powers necessary of convenient to effect its purposes:

To indemnify any person who by reason of the fact that he or she is or was a director, officer, employee or agent of the corporation to the full extent as permitted by Florida Statutes

(3) The purposes for which this organization is organized are exclusively charitable and educational within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or any future United States Internal Revenue law. Upon dissolution of the organization, assets shall be distributed to the International Reading Association after payment of debts or provisions therefore, or, if not allowable, for one or more exempt purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the federal, state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the country in which the principal office of the organization is then located, exclusively for such purpose.
