ARTICLES OF INCORPORATION
OF
CHURCH OF THE LIVING LIGHT OF THE DIVINE, INC.

A Corporation Not for Profit

The undersigned, in order to form a not-for-profit corporation for the purposes hereinafter stated, under and pursuant to the laws of the State of Florida, hereby subscribe to these Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is: Church of the Living Light of the Divine, Inc.

ARTICLE II. PURPOSE

This Corporation does not contemplate pecuniary gain or profit to the members thereof, and the purpose for which it is formed is any and all lawful purposes not for pecuniary profit for which corporations may be incorporated under Florida Corporations Not For Profit law. By way of example, such a purpose includes, but is not limited to, the worship and service of the Divine through teaching, healing, and communication of the awareness and presence of the Divine.

ARTICLE III. TERMS OF EXISTENCE

The corporation is to commence its existence on the date and at the time of filing these Articles of Incorporation with the Secretary of State, State of Florida, and shall exist perpetually thereafter until dissolved sooner according to law.
