These articles of incorporation are signed and acknowledged by the incorporators for the purpose of forming a nonprofit corporation under the Florida Nonprofit Corporation Act and to comply with 501(c) of the Internal Revenue Code as follows:

Article I. Name

The name of this Corporation shall be 'The Potter's House International Inc.

Article II, Objects

The objects or purposes of this Corporation are as follows:

- (a) To foster, develop and promote religious, missionary, charitable and educational activities, pertaining to The Potter's House International.
- (b) To do all things necessary and incident to promote the general social, benevolent and charitable works of the corporation.

Article III, Powers

Section 1

The corporation shall have all the general powers enumerated in the Florida Nonprofit Corporation Act.

Section 2

To receive and administer funds for the aforesaid purposes, and for no other purpose. On connection therewith, or incidental thereto, it shall have the right to purchase or acquire by gift, bequest, or otherwise, either directly or as trustee; and to own, hold in trust, use, sell, convey, mortgage, lease, or otherwise dispose of any real estate or chattels as may be necessary for the furtherance of its purpose; as herein stated and for no other purpose.

Article IV. Incorporators

The names and addresses of the incorporators are as follows:

Article V. Membership

The method and conditions on which members shall be accepted and discharges shall be as follows:

Membership in this Fellowship shall be eligible to all those who give evidence of their faith in the Lord Jesus Christ, and who voluntarily subscribe to its Statement of Faith, and agree to be governed by its Constitution & Bylaws, as herein set forth. They shall be classified as follows:

Section 1. Active Membership

All those whose names appear on the original membership roll of the Fellowship at the time the Fellowship was first organized, together with those names which have been added to the membership roll, shall constitute the membership for the Fellowship, providing they have experienced the new birth, meet the scriptural standards for membership, support the Fellowship financially, attend the means of grace, take part in the service, are living consistent Christian lives, and are in agreement with the distinctive testimony of the Fellowship.

Section 2. Discipline

A member who without cause absents himself from the services of the Fellowship for a period of three consecutive months or more, and/or ceases to support the ministry as verified through contributions records, shall be temporarily suspended from active membership. Unscriptural conduct, divisive behavior, or doctrinal departure from the distinctive testimony of the Fellowship, shall be considered sufficient grounds upon which any person may be removed from the membership roll.

Article VI, Officers

The Officers of the corporation shall consist of the President, Vice President, Secretary, and Treasure. The terms of the Officers shall correspond to the Corporation's fiscal year as provided in the by-laws. The Board of Directors shall consists of officers, to serve for terms of one year or untill their successors are duly nominated and appointed. The times, places and manner of selecting officers and directors shall be provided in the by-laws. The officers for the first year shall be:

Article VII, By-Laws

The Board of Directors may adopt by-laws for the governance of the Corporation.

Article VIII, Registered Office And Registered Agent

The location and address of the Corporation's initial registered office is 7184 Spoonfoot Street Orlando, Florida 32802, Registered agent is JT Pugh 7184 Spoonfoot Street Orlando, Florida 32802. The principal address is the same.

Article IX Authority

Said corporation is organized on a nonstock basis. Said corporation is to be funded under the following general plan: by contributions to it of funds and property absolutely or in any of them, any property real, personal or mixed, without limitations as to the amount or value, except such limitation, if any, as may be imposed by law; to sell, convey, and dispose of any such property and to seal with such property for any of the aforementioned purposes without limitation, except such limitations, if any, may be contained in the instrument under which property is received; and to exercise any, all, and every power for which a nonprofit corporation organized under the provisions of the Florida Nonprofit Corporation Act, and for all the public welfare can be authorized to exercise, but not any other power. No substantial part of the activities of this corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation.

Article X. Duration

This being a benevolent corporation, its term is unlimited and in perpetuity.

Article XI. Directors

The names of the Board of Directors of the Corporation chosen for the first year or until their repective successors are appointed and qualified are as follows:
