## Articles of Incorporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, pursuant to Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation.

### Article I

#### Name

The name of the corporation shall be:






