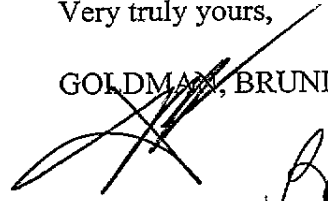

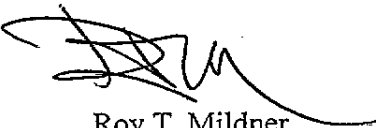

We the undersigned, hereby make, subscribe, acknowledge and file the following Articles for the purpose of forming a non-profit Corporation under the laws of the State of Florida.

ARTICLE I - NAME: The name of this Corporation is PORT ST. LUCIE YOUNG AMERICAN BOWLING ALLIANCE, IN.C.

ARTICLE II - PURPOSES: The Corporation does not contemplate pecuniary gain or profit, direct or indirect, to its members. The purposes for which it is formed are:

- (1) Creating a group for the enjoyment of young people of the community;
- (2) Promoting community involvement and creating a greater appreciation of the community by the group promoting programs of a civic, social and cultural nature which are designed to increase the values of the community;
- (3) Insofar as permitted by law, to do any other thing that, in the opinion of the Board of Directors, will promote the common benefit and enjoyment of the community.

ARTICLE III - MEMBERSHIP: Any person having an interest in the objectives of the organization shall be eligible to apply for membership which shall be regulated by the By-Laws.

ARTICLE IV - TERM: This Corporation shall have perpetual existence.
