ARTICLES OF INCORPORATION

OF

EMMANUEL CHRISTIAN FELLOWSHIP OF GREEN COVE SPRINGS, INC. (Not for Profit)

We, the undersigned residents of the State of Florida, being twenty-one years of age or more, do hereby associate ourselves together for the purpose of forming a corporation under the statutes of Florida.

ARTICLE ONE

NAME

The name of this Corporation is EMMANUEL CHRISTIAN FELLOWSHIP OF GREEN COVE SPRINGS, INC., and its location shall be 3104 Nautilus Road, Middleburg, Florida 32068.

ARTICLE TWO

DURATION

The period of duration of this Non-Profit Corporation shall be perpetual.

ARTICLE THREE

PURPOSE

The business and purpose of this Corporation shall be an outreach ministry.

ARTICLE FOUR

NON-STOCK CORPORATION

The Corporation shall be non-stock and no dividends shall be declared or paid to the members thereof.

ARTICLE FIVE

DIRECTORS

The number of directors constituting the initial board of directors of the Corporation is four, and the names and addresses of the persons who are to serve as initial directors are as follows:

ARTICLE SIX

ELECTION OF DIRECTORS

The manner in which the directors, managers, or trustees are to be elected by the members is as follows: by a majority vote of

the membership.

ARTICLE SEVEN

MEMBERSHIP REQUIREMENTS

Candidates for membership shall voluntarily subscribe to the articles of faith set forth in the Constitution of the Emmanuel Christian Fellowship of Green Cove Springs, Inc., and agree to be governed by its Constitution and By-Laws. Membership shall be terminated by death, or admission to other Church of like faith, or erasure upon becoming affiliated with another faith, or exclusion by a majority vote of the membership.

ARTICLE EIGHT

AMENDMENT

These articles may be amended in the manner provided as follows: by a two-thirds vote of all members at any regular meeting, or at a special meeting called for that purpose.

ARTICLE NINE

ELECTION OF OFFICERS

The officers shall be elected by the directors, who shall first be elected by the members of the Corporation.

ARTICLE TEN

CORPORATE OFFICERS AND THEIR FUNCTIONS

The general officers of this Corporation shall be President, Vice-President, Secretary, and Treasurer.

The principal duties of the President shall be to preside at all meetings of the members and the board of directors and to have a general supervision of the affairs of the Corporation.

The principal duties of the Vice-President shall be to discharge the duties of the President in the event of absence or disability, for any cause whatsoever, of the President.

The principal duties of the Secretary shall be to counter-sign all deeds, leases, and conveyances executed by the Corporation, affix the seal of the Corporation thereto, and to such other papers as shall be required or directed to be sealed, and to keep a record of the proceedings of the board of directors, and to safely and systematically keep all books, papers, records, and documents belonging to the Corporation, or in any way pertaining to the business thereof, except the books and records incidental to the duties of the Treasurer.

The principal duties of the Treasurer shall be to keep an account of all monies, credits, and property of any and every nature of the Corporation which shall come into the hands, and to keep an accurate account of all monies received and disbursed and of proper vouchers for monies disbursed, and to render such accounts, statements, and inventories of monies received and disbursed, and of money and property on hand, and generally of all matters pertaining to his office, as shall be required by the board

of directors.

The Board of Directors shall provide for the appointment of such additional officers as they may deem for the best interest of the Corporation.

Whenever the Board of Directors may so order, any two offices, the duties of which do not conflict, may be held by one person.

The officers shall perform such additional or different duties as shall, from time to time, be required by the Board of Directors, or as may be prescribed from time to time by the By-Laws.
