**ARTICLES OF INCORPORATION
OF
Miami All-Stars Cultural Association, Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Association shall be: *Miami All-Stars Cultural Association also known as M.A.S.C.A.*

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of the Association shall be:

ARTICLE III

PURPOSE(S)

The purposes of the Association shall be to:

- A Promote the steelpan in North America.
- B Expose second generation Trinidadians and Tobagonians to the culture of their parents and to expand the steelband to a greater North American population.
- C Foster a feeling of comradeship among the community.
- D Encourage its members to participate in Civic and Cultural affairs.
- E Inspire the desire for study of management and control of organizational processes and Civic and Cultural programs.
- F Provide opportunities for free expression, debate and public speaking.
- G Foster growth and development among all its members
- H Grant scholarships to deserving individuals.

ARTICLE IV

MANNER OF ELECTION OF OFFICERS

The Association Shall be governed by an Executive Committee.

- A **The Executive Committee** shall be elected at the Annual General meeting. The Executive Committee shall consist of the President, Vice President, Treasurer, Assistant Treasurer, Recording Secretary, Corresponding Secretary, Steelband Leader, Public Relations Officer and the Business Manager. With the exception of the **Steelband Leader** such officers shall serve for a term of one year and thereafter until their successors have been elected. In no case, shall an officer, including those appointed, hold the same office for more than three (3) consecutive years. Any vacancies occurring on the Executive Committee shall be filled at any meeting by a majority vote of the membership.
- B **The Steelband Leader** shall be elected every three (3) years and shall be evaluated annually by the Executive Committee. Only Steelband members are eligible to vote for the Steelband Leader. If after the evaluation the Steelband Leader is deemed unfit, an emergency election shall be held to elect a new leader. Such officer shall serve for a term of three (3) years and thereafter until a successor is elected.

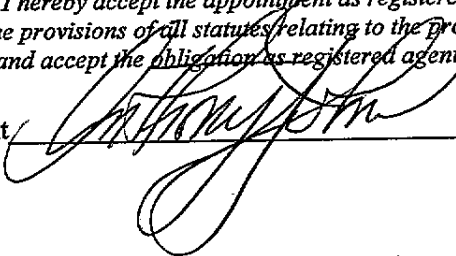
