ARTICLES OF INCORPORATION

We, the undersigned, all being sur juris, do hereby associate ourselves together and, do hereby agree for ourselves, under the laws of the State of Florida, Florida Statue 617.001 et seq., and the provisions, benefits, and obligation conferred and imposed by said laws on corporations not for profit, and adopt and subscribe to these ARTICLES OF INCORPORATION.

ARTICLE ONE
The name of this corporation shall be LOGOS GOSPEL

ARTICLE TWO
LOGOS GOSPEL TABERNACLE, INC., shall have perpetual existence

ARTICLE THREE

The general and specific purpose of LOGOS GOSPEL TABERNACLE, INC. shall be to:

- A. Preach Christ, and to teach and practice Christianity as taught in the Bible, and to carry out the principles of the Word of the Almighty God.
