*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

**ARTICLE I - NAME**

The name of the corporation shall be: TUNNEL VISION COMMUNITY OUTREACH SERVICES, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 6561 N.W. 24 CT., SUNRISE, FLORIDA 33313

**ARTICLE III - PURPOSE(S)**

The specific purpose(s) for which the corporation is organized is an educational and day care center for children between the ages of 6 months and 8 years of age.

**ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed is as follows: Elections shall be made by majority vote of the Directors. This provision may be ratified by new laws adapted by the Board of Directors.
