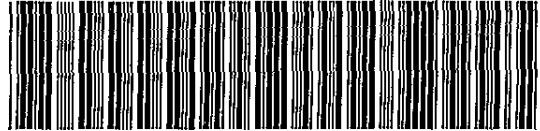

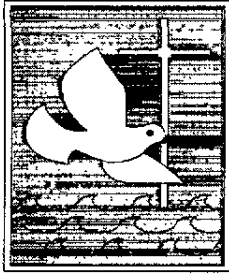


VII. ADDED
