ARTICLES OF INCORPORATION

OF

A FLORIDA NONPROFIT CORPORATION

ARTICLE I. NAME

The name of this corporation is THE HOUSE OF PRAYER, PRAISE, AND WORSHIP, Inc.

ARTICLE II. PRINCIPAL OFFICE

This is a nonprofit corporation organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act, located at 700 East Hickory Street, Sanford, Seminole County, State of Florida, 32771.

ARTICLE III. PURPOSES

The specific and primary goals for which this corporation is formed are to operate for the enhancement of spiritual growth, charity, education, and other charitable causes, by the distribution of its funds for such purposes and particularly for promoting Christian fellowship, teachings, and charitable ideals within the community.

The general purposes for which this corporation is formed are to operate exclusively for such religious, charitable, and educational purposes as will qualify it as an exempt organization under Section 501 © (3) the Internal Revenue Code of 1954 or corresponding provisions of any subsequent federal tax laws, including, for such purposes, the making distributions to organizations qualifying as tax-exempt organizations under that Code, and Section F.S. 617.0302 the

Corporate powers, which states every corporation not for profit organized under this act, unless otherwise provided in its articles of incorporation or bylaws, shall have power to: _(1) Have succession by its corporate name for the period set forth in its articles of incorporation (2) Sue and be sued and appear and defend in all actions and proceedings in its corporate name to the same extent as a natural person (3) Adopt, use, and alter a common corporate seal however, such seal must always contain the words "corporation not for profit." (4) Elect or appoint such officers and agents as its affairs shall require and allow them reasonable compensation (5) Adopt, change, amend, and repeal bylaws, not inconsistent with law or its articles of incorporation, for the administration of the affairs of the corporation and the exercise of its corporate powers (6) Increase, by a vote of its members cast as the bylaws may direct, the number of its directors so that the number shall not be less than three but may be any number in excess thereof. (7) Make contracts and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage and pledge of all or any of its property, franchises, or income. (8) Conduct its affairs, carry on its operations, and have offices and exercise the powers granted by this act in any state, territory, district, or possession of the United States or any foreign country. (9) Purchase, take, receive, lease, take by gift, devise, or bequest, or otherwise acquire, own, hold, improve, use, or otherwise deal in and with real or personal property, or any interest therein, wherever situated. (10) Acquire, enjoy, utilize, and dispose of patents copyrights, and trademarks and any licenses and other rights or interests thereunder or therein. (11) Sell, convey, mortgage, pledge, or otherwise dispose of all or any part of its property and assets. (12) Purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, lease, or otherwise dispose of and otherwise use and deal in and with, shares and other interests in, or obligations of, other domestic or foreign corporations, whether for profit or not for profit, associations, partnerships, or individuals, or direct or indirect obligations of the United States, or of any other government, state, territory governmental district, municipality, or of any instrumentality thereof. (13) Lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds loaned or invested except as prohibited by F.S. 617.0833. (14) Make donations for the public welfare or for religious, charitable scientific, educational, or other similar purposes. (15) Have and exercise all powers necessary or convenient to effect any or all of the purposes for which the corporation is organized. (16) Merge with other corporations both for profit and not for profit, domestic and foreign.

This corporation shall not, as a substantial part of its activities, carry out propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statement or otherwise) in any political campaign on behalf any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.

ARTICLE IV. ELECTION OF DIRECTORS

The corporation shall have three 3) initial board of directors, and shall not have more then 31 but, never less than three (3). The number of directors can be increase or decrease by the by laws of the corporation but, never less than three (3). There shall be three 3) directors constituting the initial board of directors.

Directors shall be elected by a majority of the initial board. The elections shall be conducted at such place, time, and date as designated by the board of directors by resolution.

ARTICLE V. INITIAL REGISTERED AGENT AND STREET ADDRESS

The street address of the initial registered office of the corporation is 700 East Hickory Street, City of Sanford, County of Seminole, State of Florida, 32772. The name of the initial registered agent at such address is Bishop BLUE

VI. MEMBERSHIP

There shall be 3 directors constituting the initial board of directors.

ARTICLE VII. INCORPORATOR

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a nonprofit fund, foundation, or corporation organized and operated exclusively for religious or charitable purposes which has established its tax exempt status under Section 501 © (3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws.
