ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

The Euclid Heights Neighborhood Association, Inc.

ARTICLE II PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

The purpose of the Association is to enhance, improve and beautify the Euclid Heights Area, which is bordered by 62nd Av. North, 46th Ave. North, 9th/MLK St., and 16th Street. Promoting the general welfare, happiness and civic pride of the real property owners, tenants and residents in the Euclid Heights Area is at the heart of this stated purpose.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

The Board of Directors shall consist of all officers as may be elected and those directors appointed by the President. At the March meeting the Active members present shall select a nominating committee of a minimum of three members. (An Active Member is any adult real property owner, tenant, or resident of the Euclid Heights Area whose household dues are currently paid.) The committee shall prepare a slate of officers and present it at the April meeting. The slate of nominees shall be circulated in the May newsletter. Elections will be held at the annual meeting in May. The prevailing candidates will be officially seated at the end of the May meeting and shall serve until new ones are elected. In the event no candidate wins a majority the two candidates with the largest number of votes will be voted on.

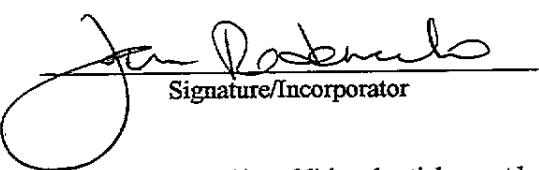
