I

The name of this Corporation is Veterans Helping Veterans Inc.

II

A. This Corporation is a Non-Profit Public benefit corporation and is not organized for the private gain of any person. It is organized under the Non-Profit public benefit corporation law for charitable purposes, to assist veterans in information and referral as well as assistance in Basic Care.

III

B. The specific purpose of this Corporation is to provide affordable Housing and Emergency Shelter. For the needy and Homeless Individuals. Also to provide Food and Independent Living Skills for those who are employable. To provide training and skills to further assist the Homeless in preparation for competitive employment.

IV

The Name and Address in the State of Florida of this corporations Initial Agent of Service of process is Larry H. Forks 2020 E. Madison St., Lake City, Florida 32055. The principal address is the same as the registered office.

V

A. This Corporation organized and operated exclusively for charitable purposes within the meaning of Section 501 C, (3) of the Internal Revenue Code.



(Including the publishing or distribution of Statements) on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any private person. upon the dissolution or winding up of the corporation. It's assets remaining after payments or provision for payment of all debts and liabilities of this corporation, shall be distributed to a non-profit fund or foundation or corporation which is organized and operated exclusively for charitable purposes and which has established it's taxed exempt status under Sec (501 C3) of the Internal Revenue Code.
