ARTICLES OF INCORPORATION  
FOR

PROMISE LAND LIFE MINISTRIES INC.

The undersigned, acting as incorporator of a Corporation Not For Profit pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I  
NAME

The name of the Corporation shall be Promise Land Life Ministries Inc.

ARTICLE II  
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal office, the principal place of business and the mailing address of the Corporation shall be 7390 Dunwalt Rd., Pensacola, FL 32526.

ARTICLE III  
PRINCIPALS AND PURPOSES

- A. The principals of this Organization shall be based upon the Bible, the inspired Word of God.
- B. The purpose of this Organization shall be to evangelize salvation and discipleship unto the Lord Jesus Christ both at home and abroad; To establish and conduct churches and issue charters to the same; Such Churches to be known as Life Centers.
- C. To establish and conduct proper organization for this Corporation, supervisory management over churches granted charters by this Corporation; and to maintain such departments necessary for the spread of the Gospel in both home and foreign lands.
- D. To establish Bible Schools, Churches, License and Ordain Ministers and Missionaries, Elders and Deacons for the furtherance of the Gospel of Jesus Christ and to oversee the spiritual and practical needs of the body.
- E. To have the right to own, hold, use, sell, convey, borrow money, mortgage or otherwise deal in real or personal property.

## ARTICLE IV MANNER OF ELECTIONS

- A. This Organization shall be established with the provision that the method of election of directors be stated in the bylaws. The bylaws of the Corporation shall be adopted at the initial meeting of the Corporation not yet determined.
- B. The Articles of Incorporation may be amended by the director/board at any qualified meeting of the said Corporation upon notice.
- C. The number of trustees may be increased or diminished from time to time according to the bylaws.
- D. The name of the initial president/secretary/treasurer of the said Corporation is John M. Simpson III, 7390 Dunwalt Rd., Pensacola, FL 32526.

## ARTICLE V STOCK

This Organization shall be a Not For Profit religious Corporation, without fixed stock or capital.

## ARTICLE VI MEMBERSHIP

The membership shall consist of the Officers, and Pastors of chartered churches, and other Ordained and Licensed Ministers, Evangelists, and Missionaries approved by the Board of Directors.

## ARTICLE VII TRUSTEES

- A. The trustees shall hold in trust property titles and deeds for all types of property associated with the Organization.
- B. The trustees shall have general supervision over all business and other affairs pertaining to this Organization and distribution of monies of incurred indebtedness.
- C. The charter pastor shall be a lifetime trustee and president of the Corporation for life.
- D. Trustees shall be owners of property other than personal property.

- E. Neither the director, nor trustees, nor board members shall be personally liable for debts or obligations of this Corporation.

## ARTICLE VIII ORDER AGAINST TAKEOVER(S)

In order to accomplish its objectives, the Corporation shall have the general powers of a Florida Corporation Not For Profit, including each of those general powers enumerated under Florida statute 607.011 Chapter 617 and Chapter 91-208, laws of Florida. To perpetually protect this local church organization in its ownership in control of its property and in its sovereignty under Christ, all ecclesiastical power and authority relative to this church shall be exercised by the pastor and trustees, and all authority relative to its buildings and land shall be exercised by this title church and the decisions title made are not subject to reversal or amendment by any other ecclesiastical body whatsoever.

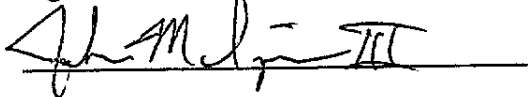
