The Undersigned subscribers to these Articles Of Incorporation are natural persons competent to contract and hereby form a Corporation not-for profit under Chapter 617.0202 of the Florida Statutes.

ARTICLE I - NAME

The name of the Corporation is **JUNTOS HAREMOS LA OBRA, CORP.**

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of this Corporation is **2050 WEST 56 STREET, SUITE 272, HIALEAH, FLORIDA 33016.**

ARTICLE III - PURPOSE OF CORPORATION

The CORPORATION is organized exclusively for CHARITABLE, RELIGIOUS, AND EDUCATIONAL purposes. The kind of organization permitted under this CORPORATION would be a CHURCH, CONVENTION or ASSOCIATION OF CHURCHES.

ARTICLE IV - BOARD OF DIRECTORS

The names and address of the persons who are the BOARD OF DIRECTORS of the CORPORATION are as follows: **Juan Carlos Mateluna, President, 2050 West 56 Street, Suite 272, Hialeah, Florida, Maria E. ARTICLE V - TERM OF EXISTENCE

This CORPORATION shall have perpetual existence.

ARTICLE VI - EFFECTIVE DATE

The date when the corporate existence of this CORPORATION shall begin, shall be when these ARTICLE OF INCORPORATION are received and accepted by the SECRETARY OF STATE OF FLORIDA.

ARTICLE VII - SURPLUS REMAINDER

No part of the SURPLUS REMAINDER of the CORPORATION shall inure to the benefit of, or be distributable to its MEMBERS, TRUSTEES, BOARD OF DIRECTORS, OFFICERS, or PRIVATE PERSONS, except that the CORPORATION shall be authorized and empowered to pay reasonable compensation for services rendered and to make attempting to influence legislation, and the CORPORATION shall not participated in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these ARTICLES, the CORPORATION shall not carry on any other activities not permitted to carried on;

A) By a CORPORATION exempt from FEDERAL INCOME TAX under SECTION 501 (C) (3) or within the meaning of SECTION 509 (A) (1) of the INTERNAL REVENUE CODE, or corresponding section of any future FEDERAL TAX CODE,

B) By CORPORATION, contribution to which are deductible under SECTION 170 (C) (2) or under SECTION 170 (B) (1) (A) (I) of the INTERNAL REVENUE CODE, or corresponding section of any future FEDERAL TAX CODE.

ARTICLE VIII - QUALIFICATIONS MEMBER

The qualifications of members to be stated in the CORPORATION BY-LAWS
The manner in which directors are to be elected shall
stated in the BY-LAWS.

ARTICLE IX - DISSOLUTION

Upon dissolution of the CORPORATION, ASSETS shall be distributed for one or more exempt purposes within the meaning of SECTION 501 (C) (3) of the INTERNAL REVENUE CODE, or corresponding section of any future FEDERAL TAX CODE, or shall be distributed to the FEDERAL , THE COURT OF COMMON PLEAS of the COUNTY in which the principal office of the CORPORATION is then located. exclusively for such purpose or to such organization or organizations as said court shall determine, which are organized and operated exclusively for purposes.

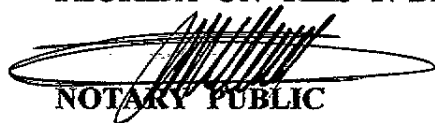

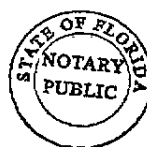
