## ARTICLES OF INCORPORATION

**OF** 

### CONSTITUTIONAL FREEDOMS COMMITTEE, INC

The undersigned, acting as incorporator of a corporation pursuant to chapter 61% Florida Statutes (the Florida Not For Profit Corporation Act), does hereby adopt the following Articles of Incorporation:

## ARTICLE I. - Name

The name of the corporation shall be: Constitutional Freedoms Committee, Inc..

# ARTICLE II. - Principal Place of Business and Mailing Address of the Corporation

#### ARTICLE III. - Effective Date and Corporate Duration

The corporation shall exist perpetually until dissolved according to law.


