The incorporator, desiring to form a corporation for non-profit under the General Corporation Law of Florida, certifies:

ARTICLE I
NAME

The name of the corporation is *L'EGLISE CHRETIENNE DE LA FRATERNITE, INC.*

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III
DURATION

The Directors of the corporation shall be elected in accordance with the bylaws.

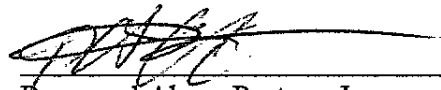
ARTICLE VI

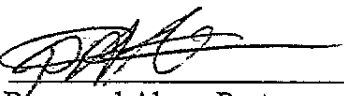

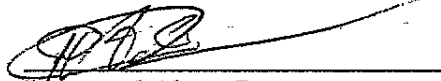
