ARTICLES OF INCORPORATION  
OF  
SON SHINE CHRISTIAN FELLOWSHIP OF JACKSONVILLE, FLA., INC.,  
A FLORIDA NON-PROFIT CORPORATION

ARTICLE I

NAME

The name of this Corporation shall be Son Shine Christian Fellowship of Jacksonville, Fla., Inc..

ARTICLE II

DURATION

The term of existence of this Corporation is perpetual, commencing on the date of the filing of these Articles of Incorporation with the Secretary of the State.

ARTICLE III

PURPOSE

The purpose for which this corporation is organized is exclusively evangelistic and charitable and is to promote the following: winning souls for Jesus Christ; provide a means for spiritual growth; strengthen families; and otherwise operate as a Christian church.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or

the corresponding provision of any future United States Internal Revenue Law or (b) a corporation contributions to which are deductible under Section 170(e)(2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(e)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or Local government for exclusive public purpose and whose character is consistent with this corporation.

#### ARTICLE IV

##### TRUSTEES

There shall be three (3) trustees. The number of trustees may be increased from time to time by the By-Laws of the Corporation, but there shall never be less than three (3).

The original Board of Trustees and Officers shall be the individuals whose names and addresses are listed below:

The trustees shall have all the rights and responsibilities of Directors.

#### ARTICLE V

##### MEMBERS

The corporation shall have members rather than stockholders. Members of the corporation will qualify for admission if they pay the dues and subscribe to the purpose of the corporation and are approved by the majority of the members.

#### ARTICLE VI

##### REGISTERED OFFICE AND AGENT

The initial registered office of the Corporation shall be 3091 Stratton Road, Jacksonville, Florida 32221, and the initial registered agent of the Corporation at that address shall be Gary P. Mallinson. The principal address and the registered office address are the same.

#### ARTICLE VII

##### INCORPORATORS

The name and address of the subscribers of these Articles of Incorporation are the individuals who have executed these Articles of Incorporation and whose address is shown under his respective name.

#### ARTICLE VIII

##### CONDUCT OF CORPORATE AFFAIRS

The conduct of the affairs of the Corporation will be managed by the President, Secretary and Treasurer of the Corporation. Any

conveyance of title to real or personal property owned by the corporation shall be executed by the President or Treasurer and attested to by the Secretary. Officers of the corporation shall be elected at the annual meeting of the corporation unless a special meeting is called for the purpose of electing an officer or officers.

#### ARTICLE IX

##### BY-LAWS

By-laws of the corporation are to be made, approved, altered, or rescinded by a majority vote of the membership.


#### ARTICLE X

##### AMENDMENTS TO THE ARTICLES

Amendments to the Articles of Incorporation may be proposed by any member and shall be adopted following a two-thirds affirmative vote by those members present at the meeting at which said proposed amendment is discussed.

The directors shall be elected according to the bylaws.
