ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be The Higher Heights Christian Baptist Fellowship, Inc.

ARTICLE II - PRINCIPAL OFFICE

The temporary place of business of this corporation is presently at the Tallahassee-Leon County Civic Center with the permanent mailing address being Post Office Box 2453, Tallahassee, Florida 32316-2453.

ARTICLE III - PURPOSE

The specific purpose for which the corporation is organized is to give visible form to the faith and fellowship to which God has called His people. We acknowledge ourselves to be a local manifestation of the universal church through which Jesus Christ ministers to the world, to incorporate worship services through a program of Christian nurture by which our members may be built up in their faith and love, through proclamation of the gospel by word and deed, and through ministering to human need in the name of Jesus Christ.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected is by the appointment of the Chief Executive Officer (CEO). The CEO is elected, when necessary according to corporation by-laws, by the two-third majority vote of at least 1/2 of the corporation membership at the time of elections.
