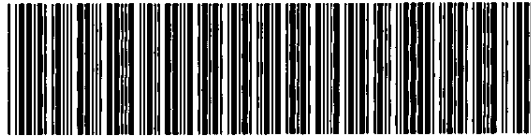

LIMITATION**

**ARTICLE 14

The power to adopt, alter, amend and repeal the Bylaws shall be vested in the Board of Trustees, but all alterations, amendments and repeals of the Bylaws must have the final approval of the Corporate President and Vice President.

In accordance with the laws of the State of Florida, the date when corporate existence shall commence is the date of subscription and acknowledge of these Articles of Incorporation.

This Corporation is organized on a nonstock basis. This Corporation shall not issue shares of stock.
