**IN RE: TRUSTEE CORPORATION OF

The undersigned incorporators hereby represent that the BLANTON FAMILY WORSHIP CENTER, Dade City, Florida, is an unincorporated body, society, or as Association engaged in the customary work of a New Testament Nondenominational Church. That in order to hold property and transact business, it is expedient that a Trustee Corporation, under the not for profit laws of the State of Florida, be created as a medium, trustee, and agency to hold in trust of the CHURCH, and to put into legal form and effect the will and directions of the CHURCH, as to her temporal or business matters.

That the CHURCH, at a regular business meeting, held on the 15th day of April, A.D. 1998, which was duly called and at which a quorum was present and voting, voted to secure the creation of a TRUSTEE CORPORATION. At said meeting, the proposed charter for the TRUSTEE CORPORATION, as hereinafter set forth, was submitted to and duly adopted by the CHURCH, and the Officers of the Board of Deacons and the Treasurer of the CHURCH instructed to execute same and to secure approval and filing of same in accordance with the law and the statutes as made and approved. Said Charter is as follows.

**ARTICLES OF INCORPORATION
OR CHARTER**

**TRUSTEE CORPORATION OF BLANTON FAMILY WORSHIP CENTER CHURCH
OF DADE CITY, FLORIDA**

The undersigned as incorporators of the Trustee Corporation of the BLANTON FAMILY WORSHIP CENTER CHURCH OF DADE CITY, INC., of Dade City, in the County of Pasco, and State of Florida, hereby associate themselves together as a corporation not for profit, under the laws of the State of Florida, pursuant to the will, instruction and direction of the Blanton Family Worship Center Church of Dade City, under the following Articles of Incorporation, as and for a religious, educational, benevolent and charitable body, medium or institution, trustee and agency, to wit:

**ARTICLE I
NAME AND LOCATION**

The name of the corporation shall be TRUSTEE CORPORATION OF THE BLANTON FAMILY WORSHIP CENTER CHURCH OF DADE CITY, INC., and it shall be commonly known and referred to as the "Board of Trustees" as distinguished from the Blanton Family Worship Center Church of Dade City, the unincorporated body, hereinafter referred to as the "Church". The place where said corporation shall be located is in Dade City, of the County of Pasco, and State of Florida, the address being 14124 7th Street, Suite 3, Dade City Florida 33525.

ARTICLE II
NATURE AND OBJECTS

The general nature and objects of this corporation shall be in accordance with the instructions and directions of the "Church" to receive and acquire by gift, devise, purchase or otherwise, real and personal property, to build, erect, construct, provide for, maintain and equip suitable buildings, church houses, etc., and to own, possess and hold for the use and benefit of the "Church" property of every description, and to sell, mortgage, bond, lease, re-lease, and dispose of the same, to sue and be sued and to enjoy all rights and privileges belonging and incident to corporations not for profit, and to, in every respect, do all things and exercise all powers which a natural person might have, do, and exercise, for the use and benefit of the "Church" and in accordance with her instructions and directions.

The corporation in its actions and functions, is to be simply a medium, trustee and agency, holding in trust the property of the "Church" and putting into legal form and effect the will, instructions and directions of the "Church", as to its temporal or business matters.

ARTICLE III
MEMBERSHIP

The membership of the corporation shall be active members of Blanton Family Worship Center Church. A minimum of three members of the Church will consist of Chairman, Vice Chairman and Secretary/Treasurer. Members of the corporation shall be elected by the members of the Church.

ARTICLE IV
TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE V

ARTICLE VI

OFFICERS

The administrative officers of this corporation shall be Chairman of the Trustees, a Vice Chairman, a Secretary/Treasurer. There shall be such other officers as the "Church" may from time to time direct and elect. Officers shall be elected annually pursuant to the Bylaws.

The minute of the corporation may be the same as the minutes of the "Church", in so far as same may pertain to the temporal or business matters of the "Church".

All deeds, bonds, mortgages, contracts or other instruments authorized or directed by the "Church" shall be executed by the Chairman, Vice Chairman and attested by the Secretary/Treasurer. In the absence or inability of one or the other of such persons to act, the corporation shall designate such other member or members of the corporation to act pro tempore, as needed.

The property held by this corporation may be sold, conveyed, bonded, mortgaged or leased only upon and pursuant to the will, instruction and direction of the "Church".

ARTICLE VII

BOARD OF TRUSTEES

The entire membership of this corporation shall constitute the Board of Trustees of this corporation; however, they shall at all times be subject to the direction and control of the "Church".

ARTICLE VIII

BYLAWS

The members of this corporation shall adopt such Bylaws and amendments thereto as shall be in accordance with the instructions and approval of the "Church", for the carrying on of the business for which this charter is granted, not inconsistent with the laws of the State of Florida, but only after vote of the "Church". The Bylaws are to be consistent and in accord with these Articles of Incorporation or Charter of the "Church" in so far as possible.

ARTICLE IX

PASTOR SECURITY

As a congregation and as a Board of Trustees, we collectively agree that Pastor Glenn Hendley cannot be removed from office of Pastor at BLANTON FAMILY WORSHIP CENTER CHURCH OF DADE CITY, INC. by a majority vote of the congregation or the Trustees unless he feels that God has called him to another work. If the Board of Trustees feel that Pastor Glenn Hendley's integrity has been compromised, they can per Galatians 6:1, restore him to the fellowship. This clause is restricted solely to Glenn Hendley as Pastor and does not apply to any future Pastors of this church.

ARTICLE X
AMENDMENT OF CHARTER

Amendments of this charter may be had only in accordance with the laws of the State of Florida, and upon a two thirds (2/3) majority vote of the Board of Trustees. Before same shall be presented to the Secretary of State for approval and filing, same shall be submitted to the "Church", in conference sitting, for it's ratification and approval, after the giving of due notice as to the time and purpose, from the pulpit for at least two Sundays next preceding the conference meeting.

ARTICLE XI

The corporation is granted all those powers allowed to it under Section 617.021, Florida Statutes, 1965.

IN WITNESS WHEREOF, under the direction and authority granted by the Church sitting in conference and due notice as prescribed the duly elected officers of the Church have hereunto set our hands and seal at Dade City in the County of Pasco and State of Florida this 27 day of April, A.D. 1998.
