ARTICLES OF INCORPORATION

We, the undersigned, for the purpose of forming a body corporate not for profit under the laws of the State of Florida, do hereby certify, make, subscribe, acknowledge and file in the office of the Secretary of State of Florida, this certificate of incorporation.

ARTICLE I:

The name of the corporation shall be Heart of God Ministries Worldwide Evangelistic Outreach, Inc., and it shall be a non-profit corporation under the laws of the State of Florida.

ARTICLE II:

The principle office and place of business of the corporation shall be 6100 West Fairfield Drive Suite B, Pensacola, Florida 32506.

ARTICLE III:

The general nature of the corporation shall be to own, manage, control, use, convey and otherwise deal in real and personal property of every nature and kind for the purpose of conducting the affairs of an Independent Christian Church Organization. The corporation shall use said properties for the purposes of promoting the Doctrines of Faith as found in the Holy Bible and shall participate in the benevolent enterprises and social services which it may deem proper and advisable in the furtherance of the Kingdom of God through the saving grace and knowledge of Jesus Christ both on a national and international scope of operations.

ARTICLE IV:

This corporation shall be established with the provision that the method of election of Directors be stated in the Bylaws. The Bylaws of the corporation shall be adopted at the initial meeting of the corporation to be held at 6100 West Fairfield Drive Suite B, Pensacola, Florida, and read into the minutes of the meeting. The Articles of Incorporation may be amended by the Directorboard at any qualified meeting of the said corporation upon notice that said corporation may by By-laws provide. The number of Directors may be increased or diminished from time to time by the Bylaws adopted at the first meeting of the corporation. The name of the person who is to serve as Chairman of the Board of Directors and Chief Executive Officer of the corporation is as Follows: Ronald E. Gann, Pensacola, Florida.

ARTICLE V:

In order to accomplish it's objectives, the corporation shall have the general powers of a Florida corporation not for profit, including each of those general powers enumerated under Florida statute 607.011 chapter 617 and chapter 91-208, laws of Florida.

ARTICLE VI:

The registered office of the corporation shall be 6100 West Fairfield Drive, Pensacola, Florida 32506.
The registered agent shall be Ronald E. Gann, 6100 West Fairfield Drive, Suite B, Pensacola, Florida 32506.

ARTICLE VII:

The name and address of the incorporator of this corporation is:

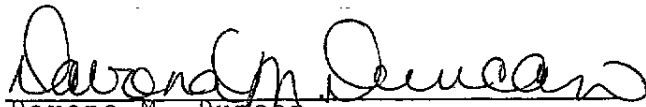
