The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **NOOR-UL-ISLAM MOSQUE, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is **2067 Americana Blvd, Suite 402, Orlando, FL 32839.**

ARTICLE III: PURPOSE

ARTICLE X: AMENDMENTS


The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
