OF

(a Florida non profit corporation)

ARTICLE I

The name of this non profit corporation shall be Bergas Aviation, Inc., hereinafter referred to as the "Corporation".

ARTICLE II

The street address of the initial principal office of the Corporation and registered office of the Corporation is located at 2843 N.E. 28th St. Ft. Laud., Florida 33306.

ARTICLE III

The initial registered agent for the Corporation shall be Irwin Beretsky whose address is: 2843 N.E. 28th St., Ft. Laud., Fl 33306.

ARTICLE IV

The purposes for which this Corporation is organized are:

1. To promote safety, and to enhance interest, in aviation as a hobby and sport by non commercial pilots and others not directly engaged in the commercial aviation profession.

2. To provide other services as determined by the Directors of the Corporation which are consistent with the purposes of the Corporation.

3. To operate without profit for the benefit of its members.

4. To insure compliance with the requirements of applicable safety regulations.

5. To perform all of the functions contemplated of the Corporation, and undertaken by the Board of Directors of the Corporation.

ARTICLE V

The Corporation shall have all powers contained in Chapter 617, Florida Statutes, and all of the powers and privileges which may be granted unto said Corporation under any other applicable

laws of the State of Florida.

ARTICLE VI

The method of election of Directors of this Corporation shall be as provided for in the by-laws of the Corporation.
