The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I Name

The name of the corporation shall be: Calvary Chapel Church, Inc.

ARTICLE II
Principal Office

ARTICLE III Purpose(s)

The specific purpose for which the corporation is organized is:

The purpose of Calvary Chapel Church is:
