## ARTICLES OF INCORPORATION

*The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

### ARTICLE I Name

The name of the corporation shall be: **Calvary Chapel Church, Inc.**

### ARTICLE II Principal Office

The principal place of business and the mailing address of this corporation shall be:

New Smyrna Beach  
Florida 32169

### ARTICLE III Purpose(s)

The specific purpose for which the corporation is organized is:

The purpose of **Calvary Chapel Church** is:

(a) Primarily to engage in the specific business of operation a church;

1. To worship God the Father, Son and Holy Spirit;
2. To upbuild the Church of Jesus Christ through the teaching of The Word and the ministry of the Holy Spirit;
3. To Persuade men and women to repent and confess Jesus Christ as Lord.

(b) To engage in the business of establishing and maintaining a church and to provide a place of public worship for the same in or near the city of New Smyrna Beach, County of Volusia, Sate of Florida, to establish, maintain and conduct schools for the religious instruction of the young, and to further the religious and charitable work, to sue and be sued in its corporate name, to make contracts and to receive property by devise or bequest, subject to the laws regulation the transfer of property by will:

(c) To carry on any business whatsoever which this corporation may deem Proper or convenient in connection with any of the foregoing purposes or otherwise, to borrow money, to lend money, to own real property, to own personal property, to have and

exercise all the powers conferred by the laws of the State of Florida upon corporations formed under the laws pursuant to and under which this corporation is formed, as such laws are no in effect or may at any time hereafter be enacted or amended:

(d) To engage in any business related or unrelated to those described in clauses (a), (b), and (c) of this Article III and from time to time authorized or approved by the board of directors of this corporation;

(e) To act as partner or joint ventures or in any other legal capacity in any transaction; and

(f) To do business anywhere in the world.

The above purpose clauses shall not be limited by reference to or inference from one another, but each such purpose clause shall be construed as a separate statement conferring independent purposes and powers upon the corporation.

#### **Article IV** **Manner of election of directors**

**The manner in which the directors are elected or appointed is as follows:**

The affairs of this corporation shall be administered by a Board of Directors, consisting of three (3) or more members, who shall be appointed by the President of this corporation, with such qualifications as shall be determined from time to time by the President, and each member of said Board shall be limited to three (3) years unless unanimous vote by Board members, which extends term for another three (3) years.

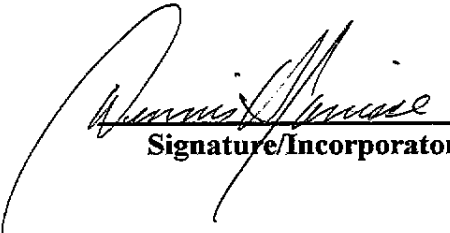
