ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statues, adopt(s) the following Articles of Incorporation:

ARTICLE 1 - NAME

The name of the Corporation shall be:

ARTICLE - III

The specific purpose(s) for which the corporation is organized is:

The purpose for which the corporation is organized is to devote and apply the assets and and/or property of the corporation and the income to be derived therefrom exclusively for charitable, religious, educational and distinct ecclesiastical purposes within the meaning of section 501 (C) (3) of the Internal Revenue code of 1986. Including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (C) (3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for one or more exempt purposes with meaning of section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal law. As the board of trustees shall determine or shall be distributed to the Federal Government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the court of common pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations. As said exclusively for such purposes.

ARTICLE - IV -MANNER OF ELECTION OF DIRECTORS

The Manner in which the directors are elected or appointed is follows:

Section 1. NOMINATION:

Nomination for election to the board of directors shall be made by a nominating committee. Nominations may also be made from the floor at annual meeting or as decided by the church congregation.

The nominating committee shall consist of a chairman, who shall be members of the church. The nominating committee shall be appointed by the board of directors prior to each annual meeting of the members, to serve from the close of such annual meeting until close of the next annual meeting and such. Appointment shall be announced at each annual meeting. The nominating committee shall make as many nominations for election to the board of directors as it shall in its discretion determine, but not less than the number of vacancies that are to file.

Section 2. ELECTION:

At such election the members or their proxies may cast, in respect to each vacancy, as many votes as they are entitled to exercise under the proving of the declaration. The persons receiving the largest number of votes shall be elected.
