B. Notwithstanding any other provision of these articles, the corporation is organized exclusively for one or more of the following purpose: religious, charitable, civic, cultural, scientific testing for public safety, literary or educational purpose or to foster national or international amateur sports competition of athletic facilities or equipment) or for the prevention of cruelty to children or animals, as specified to in Section 501 (c) (3) of the Internal Revenue Code of 1954, and shall not carry on any activities not permitted to be carried on by a corporation exempted from Federal Income Tax under section 501 (c) (3) of the Internal Revenue Code of 1954.

C. No part of the net earnings of the corporation shall inure to the benefit of any member, trustee, director, officer of the corporation or any private individual (except that reasonable compensation that may be paid for services rendered to or for the corporation) and no member, trustee, officer of the corporation or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.
