

The undersigned incorporator, , a person competent to contract for purposes of forming a corporation pursuant to Chapter 617 of the Florida Statutes, adopts the following Articles of Incorporation for said corporation.

ARTICLE I:

Name

The name of the corporation shall be The Eva J. Dixon Educational Fund, Inc.

ARTICLE II:

Existence

This corporation shall have a perpetual existence.

ARTICLE III:

Address

The street address of the initial place of business and mailing address shall be; The Eva J. Dixon Educational Fund, Inc.; 539 Johns Pass Ave., Madeira Beach, FL 33708-2368

ARTICLE IV:

Purpose

The specific purpose for which the corporation is organized is to provide parliamentary-related books to Pinellas County Public Libraries and scholarships for full time students who are conjointly studying parliamentary procedure.

ARTICLE V:

Directors

Directors: There shall be not less than three and not more than five Directors in this Corporation. The names and addresses of the first Board of Directors shall be: Barbara M. **ARTICLE VII:
Amendment**
