**ARTICLES OF INCORPORATION  
OF  
Ivory Tower Repeater Association, Inc.**

I, the undersigned subscriber, a natural person, competent to contract, hereby form a corporation not for for profit under the provisions of Chapter 607, Florida Statutes, and do hereby adopt the following Articles of Incorporation as the Charter of the Corporation.

**I. NAME**

The name of the corporation shall be:

**II. PRINCIPAL OFFICE**

**III. PURPOSE**

The general Purpose of the organization is the operation of a repeater for use by amateur radio operators licensed by the Federal Communications Commission. 
