

Article I.

Corporate Name

The name of the corporation is Bethesda World Missions, Inc.

Article II.

Principal Office and Address

The address of the principal office of the corporation is 126 NE Eglin Parkway, Fort Walton Beach, Florida 32548, and the mailing address of the corporation is 126 NE Eglin Parkway, Fort Walton Beach, Florida 32548.

Article III.

Duration

The term of existence of the corporation is perpetual; and the corporation existence will commence on the filing of these Articles by the Department of State.

Article IV.

Purpose

The purpose for which this corporation is organized is to further the works and teachings of our Lord Jesus Christ.

Article V.

Capital Stock

This corporation shall be a corporation not-for-profit and shall not issue stock.

Article VI.

Membership

The conditions and regulations of membership and the rights and other privileges of the classes of membership shall be determined and fixed by the By-Laws.

The Board of Trustees from time to time may move the Registered Office to any other address in the State of Florida.

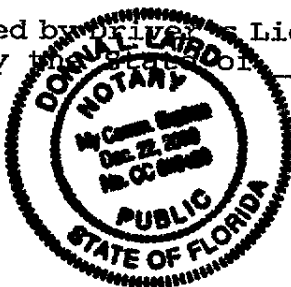
