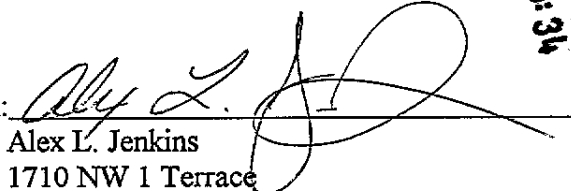

ARTICLES OF INCORPORATION
OF

ARTICLE I. CORPORATE NAME.

The name of this corporation is APOSTOLIC DELIVERANCE CHURCH OF JESUS, INC.

ARTICLE II. PRINCIPAL OFFICE.

ARTICLE III. PURPOSE OF CORPORATION

ARTICLE VI. INITIAL REGISTERED AGENT AND OFFICE.

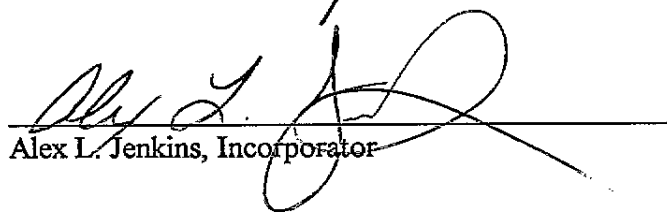
