**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as one of the incorporators of a corporation pursuant to the Florida Not For Profit Corporation Act, chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

**ARTICLE I**

**Name**

The name of the corporation shall be:

**ARTICLE II**

**Principal office and mailing address**

**ARTICLE III**

**Purposes**




