ARTICLES OF INCORPORATION

OF

SR 80 COALITION, INC.

A NOT FOR PROFIT FLORIDA CORPORATION

Pursuant to the provisions of Chapter 617, Florida Statutes, the following Articles of Incorporation are established.

ARTICLE I

NAME

The name of this not for profit corporation shall be:

SR 80 Coalition, Inc.

ARTICLE II

This not for profit corporation shall exist perpetually.

ARTICLE III

This Corporation is a not for profit corporation organized under Chapter 617, Florida Statutes, for the purpose of improving the public infrastructure in the vicinity of State Road 80 in Palm Beach County, Florida. The Corporation may exercise all rights and powers conferred by the laws of the State of Florida upon not for profit corporations.
